INTRODUCTION

This privacy policy ("Policy") describes how Radiant Heating Solutions (T/A Radiant Renewables) ("RR"), Old Barn, Hougham Mill Lane, Marston, Grantham, Lincolnshire, NG32 2FU ("Company," "we," and "our") processes, collects, uses and shares personal data when using this RR website (the "Site"). Please read the following information carefully to understand our practices regarding your personal data and how we will process your data.

1. What is personal data?

We collect information about you in a range of forms, including personal data. As used in this Privacy Policy, "personal data" is as defined in the General Data Protection Regulation, this includes any information which, either alone or in combination with other information we process about you, identifies you as an individual, including, for example, your name, postal address, email address and telephone number. **Why do we need your personal data?** We will only process your personal data in accordance with applicable data protection and privacy laws. We need certain personal data in order to provide you with access to the Site. If you registered with us, you will have been asked to tick to agree to provide this information in order to access our services, purchase our products, or view our content. This consent provides us with the legal basis we require under applicable law to process your data. You maintain the right to withdraw such consent at any time. If you do not agree to our use of your personal data in line with this Policy, please do not use our Site.

2. Collecting Your Personal Data

We collect information about you in the following ways: Information You Give Us. This includes:

- the personal data you provide when you register to use our Site, including your name, postal address, email address, telephone number, username, password and demographic information (such as your gender); Note: Currently, there is no need to register in order to use our website, but this might change in the future.
- the personal data that may be contained in any video, comment or other submission you upload or post to the Site, such as joining our mailing list of using our online enquiry form;
- the personal data you provide in connection with our rewards program and other promotions we may choose to run on the Site, from time to time;

Information Automatically Collected. We automatically log information about you and your computer or mobile device when you access our Site. For example, when visiting our Site, we log your computer or

mobile device operating system name and version, manufacturer and model, browser type, browser language, screen resolution, the website you visited before browsing to our Site, pages you viewed, how long you spent on a page, access times and information about your use of and actions on our Site. We collect this information about you using cookies. See also the section on Cookies below. Automated Decision Making and Profiling. We do not use your personal data for the purposes of automated decision-making. However, we may do so in order to fulfil obligations imposed by law, in which case we will inform you of any such processing and provide you with an opportunity to object.

3. COOKIES

What are cookies? We may collect information using "cookies." Cookies are small data files stored on the hard drive of your computer or mobile device by a website. We may use both session cookies (which expire once you close your web browser) and persistent cookies (which stay on your computer or mobile device until you delete them) to provide you with a more personal and interactive experience on our Site. Please be aware that this Site uses session cookies to save information on your computer to help our website provide you with a better user experience. Overall, cookies help us provide you with a better Site experience by allowing us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any personal information about you, other than the data you choose to share with us. When you visit any website, it may store or retrieve information on your browser, mostly in the form of cookies.
