INTRODUCTION

This privacy policy (“**Policy**”) describes how **Radiant Heating Solutions (T/A Radiant Renewables) (“RR”), Unit 5, Baker Business Park, Sellwood Court, Sleaford, NG34 8YX (“Company,” “we,” and “our”)** processes, collects, uses and shares personal data when using this **RR** website (the “**Site**”). Please read the following information carefully to understand our practices regarding your personal data and how we will process your data.

1. What is personal data?

We collect information about you in a range of forms, including personal data. As used in this Privacy Policy, “personal data” is as defined in the General Data Protection Regulation, this includes any information which, either alone or in combination with other information we process about you, identifies you as an individual, including, for example, your name, postal address, email address and telephone number. **Why do we need your personal data?** We will only process your personal data in accordance with applicable data protection and privacy laws. We need certain personal data in order to provide you with access to the Site. If you registered with us, you will have been asked to tick to agree to provide this information in order to access our services, purchase our products, or view our content. This consent provides us with the legal basis we require under applicable law to process your data. You maintain the right to withdraw such consent at any time. If you do not agree to our use of your personal data in line with this Policy, please do not use our Site.

2. Collecting Your Personal Data

We collect information about you in the following ways: **Information You Give Us**. This includes:

- the personal data you provide when you register to use our Site, including your name, postal address, email address, telephone number, username, password and demographic information (such as your gender); **Note: Currently, there is no need to register in order to use our website, but this might change in the future.**
- the personal data that may be contained in any video, comment or other submission you upload or post to the Site, such as joining our mailing list or using our online enquiry form;
- the personal data you provide in connection with our rewards program and other promotions we may choose to run on the Site, from time to time;
- the personal data you provide when you report a problem with our Site or when we provide you with customer support;
- the personal data you provide when you make a purchase through our Site; and
- the personal data you provide when you correspond with us by phone, email or otherwise.

Information from Social Networking Sites. Our Site includes interfaces that allow you to connect with social networking sites (each an “SNS”). If you connect to an SNS through our Site, you authorise us to access, use and store the information that you agreed the SNS could provide to us based on your settings on that SNS. We will access, use and store that information in accordance with this Policy. You can revoke our access to the information you provide in this way at any time by amending the appropriate settings from within your account settings on the applicable SNS. Information Automatically Collected. We automatically log information about you and your computer or mobile device when you access our Site. For example, when visiting our Site, we log your computer or

mobile device operating system name and version, manufacturer and model, browser type, browser language, screen resolution, the website you visited before browsing to our Site, pages you viewed, how long you spent on a page, access times and information about your use of and actions on our Site. We collect this information about you using cookies. See also the section on Cookies below. Automated Decision Making and Profiling. We do not use your personal data for the purposes of automated decision-making. However, we may do so in order to fulfil obligations imposed by law, in which case we will inform you of any such processing and provide you with an opportunity to object.

3. COOKIES

What are cookies? We may collect information using “cookies.” Cookies are small data files stored on the hard drive of your computer or mobile device by a website. We may use both session cookies (which expire once you close your web browser) and persistent cookies (which stay on your computer or mobile device until you delete them) to provide you with a more personal and interactive experience on our Site. Please be aware that this Site uses session cookies to save information on your computer to help our website provide you with a better user experience. Overall, cookies help us provide you with a better Site experience by allowing us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any personal information about you, other than the data you choose to share with us. When you visit any website, it may store or retrieve information on your browser, mostly in the form of cookies. This information might be about you, your preferences or your device and is mostly used to make the website work as you expect it to. In general, cookies are used to retain user preferences, store information for things like shopping carts, and provide anonymous visitor tracking data to third party applications like Google Analytics. We use traffic log cookies on this website to identify which web pages are being visited by our customers. This helps us to analyse data about our web page traffic and make improvements to our website. We only use this information for statistical analysis purposes and then the data is removed from the system. As a rule, cookies will make your browsing experience better. However, you may prefer to disable cookies on this Site and on others. The most effective way to do this is to disable cookies in your browser. although this may prevent you from taking full advantage of the website. Cookies we use Our Site uses the following types of cookies for the purposes set out below:

Essential Cookies	These cookies are essential to provide you with services available through our Site and to enable you to use some of its features. For example, they allow you to log in to secure areas of our Site (should we wish to offer this option in the future) and also help the content of the pages you request load quickly. Without these cookies, the services that you have asked for cannot be provided, and we only use these cookies to provide you with those services.

Functionality Cookies	These cookies allow our Site to remember choices you make when you use our Site, such as remembering your language preferences, remembering your login details and remembering the changes you make to other parts of our Site which you can customise. Note that this type of functionality is not currently available on our website, but could be offered in the future. The purpose of these cookies is to provide you with a more personal experience and to avoid you having to re-enter your preferences every time you visit our Site.
Analytics and Performance Cookies	These cookies are used to collect information about traffic to our Site and how users use our Site. The information gathered does not identify any individual visitor. It includes the number of visitors to our Site, the websites that referred them to our Site, the pages they visited on our Site, whether they have visited our Site before, and other similar information. We use this information to help operate our Site more efficiently, to gather broad demographic information and to monitor the level of activity on our Site. We use Google Analytics for this purpose. Google Analytics uses its own cookies. It is only used to improve how our Site works. Social Media Cookies	These cookies are used when you share information using a social media sharing button or “like” button on our Site or you link your account or engage with our content on or through a social networking website such as Facebook, Twitter or Google. The social network will record that you have done this.

Disabling cookies You can typically remove or reject cookies via your browser settings. In order to do this, follow the instructions provided by your browser (usually located within the “settings,” “help” “tools” or “edit” facility). Many browsers are set to accept cookies by default, until you change your settings. If you do not accept our cookies, you may experience some inconvenience in your use of our Site. For example, we may not be able to recognize your computer or mobile device and you may need to log in every time you visit our Site.

4. Using Your Personal Data

We may use your personal data as follows:

- to operate, maintain, and improve our Site, products, and services;
- to manage your account, including to communicate with you regarding your account, if you have an account on our Site;

- as we believe necessary or appropriate (a) to comply with applicable laws; (b) to comply with lawful requests and legal process, including to respond to requests from public and government authorities; (c) to enforce our Policy; and (d) to protect our rights, privacy, safety or property, and/or that of you or others;

- as described in the “Sharing of your Personal Data” section below.

5. Sharing Your Personal Data

We may share your personal data as follows:

- **Third Parties Designated by You.** We may share your personal data with third parties where you have provided your consent to do so.
- **Our Third Party Service Providers.** We may share your personal data with our third party service providers who provide services such as data analysis, payment processing, information technology and related infrastructure provision, customer service, email delivery, auditing and other similar services, necessary to operate our business efficiently.

6. Third Party Sites

Our Site may contain links to third party websites and features. For example Facebook, Twitter and other social networks. This Policy does not cover the privacy practices of such third parties. These third parties have their own privacy policies and we do not accept any responsibility or liability for their websites, features or policies. We use a third party service called “Shrunk Punk” on our website. This service is provided by Midsummer Energy Ltd. Midsummer Energy Ltd will collect your personal data for the purpose of providing an estimated cost to install a heat pump system at your residential property, and if requested by you, your data will be passed on to third-party companies like ourselves so we can contact you with more information. 10. Retention

We will only retain your personal data for as long as reasonably required for you to use the Site, until you close your account/cancel your subscription, unless a longer retention period is required or permitted by law (for example for regulatory purposes).

11. Our Policy on Children
